Antecedent Modification Gradual exposure to social situations starting with less anxiety provoking contexts Behavior Modification Social skills training to enhance communication and interaction skills Consequence Modification Reinforcement for attending social events and engaging in social interactions Cognitive restructuring to challenge negative selftalk
